Notice of Postal Ballot has been sent only through electronic mode to those shareholders whose names appear in the Register of Members/List of Beneficial Owners as received from Registrar & Share Transfer Agent, National Securities Depository Limited (NSDL) / Central Depository Services (India) Limited (CDSL) as on Friday, December 9, 2022, (Cut-off date) and who have registered their e-mail addresses, in respect of electronic holdings, with the Depositories through the concerned Depository Participants and in respect of physical holdings with the Company's Registrar & Share Transfer Agent (RTA) i.e. Kfin Technologies Limited.

4. The Company has engaged the services of Central Depository Services (India) Limited ("CDSL") as the agency to provide electronic voting facility. The detailed procedure and instructions for e voting are given in the Notice of Postal Ballot.
