The proceedings were related to the alleged demand of tax dues amounting to Rs. 51,86,59,521/- along with interest and penalty for the period 2018-19 and 2020-21. The order cites that "No suppression of outward tax liability has been found on account of variance between E-way Bills and GST returns. Further, it has been held that Input Tax Credit (ITC) has been correctly availed. Accordingly, No further action is warranted in this matter.
