shares either in physical form or in dematerialized form, as on the cut-off date 2020 may cast their vote electronically on the business as set out in the Notice of the 32<sup>nd</sup> AGM through electronic voting system ("remote e-Voting") of National Securities Depository Limited ("NSDL"). All the members are informed that: as set out in the Notice of the 32<sup>nd</sup> AGM will be transacted through remote e-Voting system at the AGM;

Voting shall commence on Monday, 10<sup>th</sup> August 2020 at 9:00 am IST; Voting shall end on Wednesday, 12<sup>th</sup> August 2020 at 5:00 pm IST; and, for determining the eligibility to vote through remote e-Voting or the e-Voting system during the 32<sup>nd</sup> AGM, is 7<sup>th</sup> August 2020;

Voting module shall be disabled after 5:00 pm IST on 12<sup>th</sup> August 2020; who becomes Member of the Company after sending the Notice of the AGM and holding shares as on the cut-off date i.e. 7<sup>th</sup> August 2020, e login ID and password by sending a request at evoting@nsdl.co.in or evoting@evonik.com. 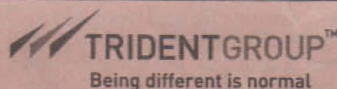

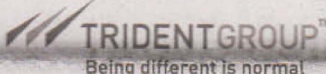
