Further, it has been held that Input Tax Credit (ITC) has been correctly availed.	The proceedings initiated under Show Cause Notice has been dropped by the Office of the Principal Commissioner, Central Goods and Services Tax, Commissionerate, Ludhiana, Accordingly, No further action is warranted in this matter.
