- Co-gen Power Plant / Solar Power Plant
- Multi-Specialty Mini Health Centre

The aforesaid projects shall be eligible for various incentives & benefits under Mega Project Policies of the State and Central Govt and are <u>subject to technical feasibility</u>, <u>financial viability and evaluation</u>.

Further, the schedule of implementation shall be in phased manner as may be approved by the Board from time to time, after financial closure & evaluation of all opportunities that will maximize value and is in the best interest of the Company and its stakeholders.
