Expected quantum of loss/damage caused	<p>In the Raw Material Yard of the Paper division and surrounding areas of the Company at Dhaula (Punjab) location, a fire accident has occurred on the evening of June 05, 2024.</p> <p>The fire resulted in major damage to the Raw Material and adjacent areas. However, no casualties were reported and there has been no damage to the plant &amp; machinery. The operations were suspended as precautionary measure and are resumed today, for both, Home Textiles and Paper businesses.</p> <p>We are proactively monitoring the situation and have taken necessary steps for the safety and well-being of the people as well as to reduce the impact on the business operations.</p> <p>The actual quantum of loss / damage is being ascertained.</p>
Whether loss/damage covered by insurance or not including amount	The Loss/damage is adequately covered by Insurance, and the Company has already informed the Insurance Company about the fire Incident.
Estimated impact on the production/operations in case of strikes/lock outs	Not Applicable
